I am requesting funding for priority resurfacing at five locations - Southern State Parkway from Route 231 to the Sagtikos State Parkway, Joshua's Path (Route 111) from Suffolk Avenue to Interstate 495 (Long Island Expressway), Route 27 (Sunrise Highway) North Service Road from Manor Road to Udall Road, Route 27 (Sunrise Highway) South Service Road from Udall Road to Malts Avenue, and Route 25A (Main Street) from Lawrence Road to Route 25/Route 25A.

The project sponsor for this project is New York State Department of Transportation and the project is located in Babylon, Islip and Smithtown, NY.

The funding is designated for pavement renewal for the five locations mentioned above.

The project is an appropriate use of taxpayer dollars and would benefit the First Congressional District of New York, because it will enhance safety and extend the service life of the facilities for ten years.
